DID YOU KNOW?

To date, the Safe Harbour Program has presented to 23 different agencies reaching over 932 people. Topics discussed ranged from human trafficking 101 awareness sessions, discussing HR4980 requirements, the Safe Harbour referral process and more. Trainings included presentations geared toward high school students, adults and service providers within the Niagara County area.



Message from Coordinator

The Safe Harbour program is underway! As of October 2015, I started providing services to at risk youth and the referrals have been steady with the passing of HR4980: The Preventing Sex Trafficking and Strengthening Families Act. This act mandates local Departments of Social Services and contracted Voluntary Agencies to identify, document and determine appropriate services for any child or youth who the state has reasonable cause to believe is, or is at risk of being, a victim of sex trafficking. Youth can fall into three categories of risk. I typically receive referrals for youth who fall into the Confirmed or High Risk categories. A Confirmed case simply means that the youth meets the Federal definition as a child sex trafficking victim where as a high risk case is when a child exhibits indicators that are commonly associated with sex trafficking, causing serious concern.

Program Needs Assessment

As part of the Safe Harbour grant, OCFS provided funding to support development of a local response; provide professional training, public awareness, and community outreach; and to support survivors and youth at risk of child trafficking. Dr. Dana Radatz from Niagara University conducted a community needs assessment to support these efforts.

Some Key Findings:

- 64 % of survey respondents had attended a human trafficking training
- 54 % reported they and/or their organization had worked with individuals who may have been survivors of human trafficking
- 61% felt “somewhat prepared” to work with a trafficking case
- 72% agencies felt their organization could play a role in addressing the human trafficking problem in Niagara County
